Dear Valued Customer,

The Oklahoma Rural Water Association (ORWA) recently conducted an extensive rate study for Wagoner County RWD#4 which was concluded prior to the March 14, 2023 Board of Director's meeting. In that meeting, the Board voted to approve the recommendations of the ORWA which included a tiered rate structure and rate adjustment that will take effect in the July 2023 billing cycle. Under the new rate structure, 80% of our customers will only see an increase of \$2.50 per month or less. It is important to note that, according to the Oklahoma Rural Water Association (ORWA), even with this increase, the water provided by Wagoner County RWD#4 is still among the most inexpensive in the state.

This adjustment is designed to cover the increased operation and maintenance expenses of the district, as well as improvements to the aging water and wastewater infrastructure. Much of the infrastructure within the District has been in service for over 50 years and will eventually need major components replaced and/or upgraded.

Upgrades to an aging infrastructure are always costly but necessary to keep up with the growing demand for high quality potable water. This rate adjustment will ensure that we continue providing the best quality water service possible to our customers both today and for generations into the future.
